## Did you know...

Proper fire extinguisher maintenance not only ensures compliance with fire codes but also plays a critical role in preventing small fires from becoming major disasters.

In order to ensure your extinguishers are ready when you need them, pay special attention to:

- **Mandatory Inspection Intervals:** Extinguishers require monthly visual inspections and annual maintenance checking for visible damage, service intervals, pressure gauge readings, proper type and accessibility.
- **Hydrostatic Testing:** is needed every 5 to 12 years. This process ensures the cylinder is safe for use, fit for purpose.
- **Chemical Recharging:** After use, even if only brief, extinguishers must be recharged immediately.
- **Expiration Dates:** Extinguishers typically have a lifespan of 10-15 years. Beyond this, the integrity of the cylinder and internal components might degrade, even if they appear functional.
- **Documentation:** Maintenance checks are logged on a approved service tag attached to the extinguisher to prove compliance during audits or inspections.
