- Blanket the fuel source of a fire, cutting off its oxygen supply and preventing reflash.

Fire suppression systems must be maintained according to NFPA 17 and NFC standards. This includes semi-annual and annual inspections and servicing by OEM trained fire protection technicians, to ensure they are fully operational in emergencies.

Regular maintenance of fire suppression systems reduces the risk of equipment damage from fires, ensuring minimal downtime and extending the lifespan of costly machinery.
